Rates may vary due to credit rating and checking/auto pay relationship, with rates as low as 4.99%^{APR}. The "Holiday Cash" loan will then be paid back over a 10-month period. "Holiday Cash" dollars can be used for your holiday purchases anywhere you want to shop.
